On 19 March 2015 Ageas Hybrid Financing ("AHF") announced its intention to invite the holders of its €500,000,000 5.125% Perpetual Securities (of which €336,364,000 are still outstanding) (the "Securities") to tender their Securities for purchase for cash (such invitation the "Offer"). The Offer is conditional on the New Financing Condition, being the successful completion (in the sole determination of AHF) of the new issue of Fixed Rate Reset Dated Subordinated Notes due 2047 to be issued by AG Insurance SA/NV (the "New Securities").

The Offer was made on the terms and subject to the conditions set out in the Tender Offer Memorandum dated 19 March 2015 (the "**Tender Offer Memorandum**"). Capitalised terms used in this announcement but not defined herein have the meanings given to them in the Tender Offer Memorandum.

The Expiration Deadline for the Offer was 4.00 p.m. (Luxembourg time) on 27 March 2015.

Acceptance

AHF announces that €241,218,000 of the Securities, or 71.71% of the aggregate nominal amount outstanding, were tendered at a Purchase Price of 103% of the nominal amount of the Securities.

AHF hereby accepts for purchase all tendered Securities in full, subject to the satisfaction or waiver of the New Financing Condition which is expected to be announced by AHF on 31 March 2015.

After settlement of the Offer, €95,146,000 of the Securities will remain outstanding.

New Financing Condition

AG Insurance SA/NV has successfully placed the New Securities in an amount of €400,000,000 at an initial fixed interest rate of 3.50% per annum until 30 June 2027 (the "First Call Date") and thereafter at a reset fixed rate of interest, which will be reset on the First Call Date and on each fifth anniversary of the First Call Date. Upon settlement of the issue of the New Securities which is expected to take place on 31 March 2015, Ageas Hybrid Financing expects to announce that the New Financing Condition has been fulfilled.

Settlement

Subject to satisfaction or waiver of the New Financing Condition, settlement of the Purchase Price and the Accrued Interest Payment is expected to take place on 31 March 2015.
